- VINTAGE DOMESTIC** American made 1979-older stock or custom.

- VINTAGE IMPORT** European or Asian made 1979-older stock or custom.
\$250
- SEMI CUSTOM** Factory stock except for exhaust, handlebars, seat air cleaner and similar minor modifications. No frame, front end, fuel tank or fender modifications other than paint or chrome. Can have chrome accessories. (American Ironhorse, Bourget's, Big Dog, Arlen Ness, etc. DO NOT qualify in this class)

- CUSTOM** Stock, modified stock, or aftermarket frame; body modifications, metal fabrication, or significant modifications. Includes production custom bikes, ie: American Ironhorse, Bourget's, Big Dog, Arlen Ness, etc.

- RADICAL** Bikes with custom frame, molding, handmade parts and extensive modifications must enter this class.

All entrants must register at the Justice Center between **9:00 and 11:00 a.m.** SATURDAY, FEBRUARY 27TH 2010 to receive your registration number and placement for the show. Viewing and judging starts at **12:00 p.m.** Trophies and awards will be presented on the Main stage (E. Indiana Avenue) around **4:00 p.m.** Bikes must start to qualify for entry.

Judges will review all bikes but only those identified as potential winners will be judged in detail.
